2 – The true and actual amount that was deposited in the TAG account for each year, or at least the true and actual amount that was credited to the TAG program for each of those years.

Response – First of all, there is not TAG "account". The amounts listed above are the amounts that were part of state foundation aid, for each year, that were TAG funds. There is no "deposit" of funds into TAG, only a coding of funds in the TAG line item of the General Fund.

3 - The true and actual amount of TAG money that is in the TAG account as of now, including any rollover from the years that there was no TAG program.

Response – The amount of state foundation aid that is listed as TAG for ${\rm FY}12$ and has been coded into TAG this year is \$56,513.00

4 – The amounts of TAG monies that were borrowed, taken, or otherwise assigned to accounts other than TAG for these same FY's

Response – At this time, and until the State Auditor finishes their audit, there were no "TAG" funds borrowed or taken or assigned to other accounts to my knowledge. The State Auditor will tell us if any funds were coded incorrectly, taken, or borrowed.
